# 4.11 Draft Lassen County 2023 Regional Transportation Plan

Genevieve Evans provided a status update on the preparation of the 2023 Regional Transportation Plan. She provided an overview of the need for the RTP, the elements that make up the document, how both City and County staff assisted the LCTC in updating the various lists of capital and rehabilitation projects, the environmental documentation needed and next steps.

The RTP is out for public review and comment. Depending on input, staff anticipates bringing the final document to the Commission for adoption at their November meeting.

This was an information item. No action was required from the Commission.

# 4.12 Draft Lassen County 2023 Regional Transportation Plan

Executive Secretary John Clerici updated the Commission of the status of the 2024 State Transportation Improvement Program. He noted that the current fund estimate for the 2024S TIP for Lassen County is approximately \$6,600,000 with approximately

\$2,600,000 in unprogrammed carryover from the 2022 STIP, and \$4,00,000 of new programmable capacity.

He added how staff working with City and County staff to develop a list of projects to be nominated

He added that since the summer Commission staff has conferred with City of Susanville, Lassen County, and Caltrans staff to determine the best mix of projects to be included in the 2024 STIP. This has included detailed re-evaluation of projects being carried over from the 2022 STIP, and potential new projects to be nominated as part of the 2024 cycle. It also takes into consideration actions to amend projects in the 2022 STIP to address cost increases and scope re-evaluation. These actions include:

- The Southeast Gateway Project being moved to construction year 2023-24 (excluding the new sign)
- Budget augmentation to County Rehab D (PPNO 02-2600) Standish Road (County Road 301), US 395 to Honey Girl Road
- Budget Augmentation to County Rehab E (PPNO 02-2601) Standish Road (County Road 301), Mapes Lane to US 395
- Non-STIP budget augmentation to Riverside Drive Class 1 Bike Ped Project (PPNO 02-2480) received construction funding from the Active Transportation Program and the Clean California program. Construction is scheduled for the summer of 2024.

In addition the Janesville Main Street Bike/Ped project (PPNO 02-2261) after evaluation by Lassen County public works staff, and public input, will be deleted from the STIP. The funds (\$40,000) will be returned to Lassen County's STIP share for this cycle.

*New projects being recommended for the STIP include:* 

- Rehab F: Rehab section of A1 from Hwy 139 to MP 5 (5mi), cost 3.217mm Note: The County has been shortlisted for a Federal Lands Access Program (FLAP) project on the Hwy 36 end of A1 so that may impact the ultimate programming of this project. Estimated cost is \$3,200,000.
- Rehabilitation project FE Approximate cost \$2,600,000 Estimated construction year – 2025
  - South Lassen Cypress to Susan River
  - Alexander Riverside to Sierra
  - o Russell Main to 200 feet south of Bunyan
  - o Fair Drive Main to Russell
  - o Johnstonville Skyline to Riverside
  - Paiute Skyline to Glenn

John reported that the final RTIP will be brought back to the Commission at the December Regular meeting for adoption.

# REQUESTED ACTION

BY MOTION: Adopt Resolution 23-12 approving Amendment #1 to the Fiscal Year 2023/24 Overall Work Program and Budget.

# PAST ACTION & DISCUSSION

At your May 5, 2023, Regular Meeting you approved the FY23/24 Overall Work Program and Budget (OWP) for the Lassen County Transportation Commission. The OWP was subsequently received and approved by Caltrans and notification of such was sent to the Executive Secretary by email on June 22, 2023.

Since then, there have been several developments that require this mid-year amendment to the FY 23/24 OWP. The changes include:

Rural Planning Assistance Carryover Funds

In any given fiscal year, the LCTC receives \$230,000 in RPA funds. This funding allows LCTC staff to perform many of the critical tasks described in the OWP. Most of these tasks are focused on regional transportation planning and the maintenance of the Regional Transportation Plan. In most years the funds are expended completely. Occasionally they are not, and there is a formula for returning a portion of the unused RPA funds as carryover to the next FY. These funds can be used to augment existing OWP activities or be used to initiate new work not anticipated when the OWP was originally developed. For this fiscal year we will be spreading the RPA carryover (\$3,500) to existing OWP work elements. They include:

WE 603 Community Outreach

In addition to the allocation of Carryover RPA funds staff is making the following additions:

WE 706 - Lassen GIS Plan

The LCTC was notified by Caltrans that they had been successful in their application for a Sustainable Transportation Planning Grant to update Countywide GIS resources. The grant funds would augment an existing update being pursued by Lassen County and would bring in the City of Susanville and the Susanville Indian Rancheria. The grant amount is \$129,829 with a match of \$16,821 (provided through labor and general funds from Lassen County). The grant will be administered by Lassen County, with the LCTC facilitating invoicing and contract oversight. This effort is anticipated to go through the end of fiscal year 24/25.

# Other Minor OWP Edits

There are other minor edits to the OWP to address grammatical and typing errors, small adjustments to deliverable dates, small adjustment to individual work element budgets, and generally to clean up the document.

The revised budget (with changes) and the revised Work Element pages are provided with this report. A fully revised OWP with accompanying resolution (23-12) and other documentation will be forwarded to Caltrans D2 staff.

# Introduction

The Lassen County Transportation Commission (LCTC) is the Regional Transportation Planning Agency for Lassen County that includes representatives from the City of Susanville, Lassen County, as well participation from the Susanville Indian Rancheria. As a rural, underserved community, Lassen County lacks the staffing capacity and funds to progress our GIS capabilities and therefore, the region lacks the tools to gather and represent data that showcase our current planning and transportation needs and areas of opportunity. A collaborative GIS Plan, which includes the County, City, and Susanville Indian Rancheria, would identify where the GIS database updates are needed and provide a framework for the implementation of a public facing web portal which would allow the public to access important planning and transportation information. Furthermore, with more accurate records, the region can more easily plan for and implement multi-modal transportation projects listed in the Lassen County Active Transportation Plan, the Caltrans District 2 Active Transportation Plan, and Assembly Bill No. 1150, which may reduce vehicle miles traveled and therefore, greenhouse gas emissions.

Much of the limited GIS data available through the County's desktop and online GIS applications has not been updated in quite some time. This makes for an inaccurate database and causes inefficiencies within departments. The County, City, Susanville Indian Rancheria, and other employers have a similar struggle in recruiting talent which leaves often less staffing capacity to achieve the goals of our community. Fortunately, the County put out an RFP for GIS services and is now under contract with a consulting firm to help improve our data and data sharing capabilities. The first task will be the preparation of a GIS Strategic Plan which includes a Needs Assessment. Other tasks include implementing a public web portal, addressing tool, parcel layer updates and corrections, zoning and designation layer updates, roads layer updates, data mining/integration, GIS training, and creating new GIS layers.

The GIS Strategic Plan will identify the most efficient and effective way for updating and coordinating GIS databases throughout the region. With accurate GIS databases, the region can identify the locations of greatest need for multi-modal improvements, safety improvements, flooding risk and wildfire evacuation routes in a manner that is equitable to all residents of this disadvantaged community.

# Task 1: GIS 5-year Strategic Plan

The GIS Strategic Plan will define the technical and business objectives of a GIS Program which will provide a guide to assess whether individual tactical initiatives are consistent with the overall strategy of what Lassen County (including the Lassen Transit Service Agency), the City of Susanville, and the Susanville Indian Rancheria are trying to accomplish with geospatial technology. This effort will articulate not only where the participating organizations are going and the actions needed to make progress, but also how we will know if it is successful. The plan will be used to communicate goals, actions needed to achieve those goals and all of the other critical elements developed during the planning exercise.

A GIS Needs Assessment will focus on data gathering and listening to the needs and ideas of all stakeholders through public engagement and stakeholder consultation. A series of tailored questionnaires and interviews will be administered and presented to all stakeholders in the form of a kick-off presentation and technology seminar. A Needs Assessment will be provided that will document and discuss the key implementation issues and departmental needs (e.g. updates to certain GIS layers, public web portals to display certain information, data organization, etc.). The briefing will include a draft and final executive-level summary to all stakeholders that will include a one-hour presentation and an opportunity for discussion and feedback.

An alternative system-level design will be developed that will meet, to a greater or lesser extent,

all the needs, constraints, and priorities of the Lassen County Transportation Commission, Lassen County, the City of Susanville, and the Susanville Indian Rancheria in terms of performance, effectiveness, sustainability, and economics. A high-level return on investment analysis will include a strategy for improving the involved agencies' business processes using geo-spatial technology while maximizing the benefit and value of GIS technology. The business plan will note the return to be gained from achieving the goals and objectives of the plan.

A draft and final GIS Strategic Plan will be provided based on the above-mentioned items and will include a list of actions to be taken by the involved agencies organized into a matrix of priority outcomes.

# Task 2: Public Web Portal

This task will include the plan, design, build, and implementation of a GIS public web portal application that will meet all the requirements of the agencies involved, including but not limited to, providing access to data published in ArcGIS Online, zoning, land us designation information, and any other information that is determined through the Needs Assessment that would be beneficial for the community and would reduce vehicle miles traveled by not having to drive to various agencies for information that they currently cannot look up.

A public-facing web portal based on updated data would significantly benefit the County and specifically the transportation system by helping decision-makers visualize critical needs for Lassen County (e.g. location of bus stops, where road and/or sidewalk improvements are needed, trail connectivity, etc.); communicating data effectively between departments and with the public; enhancing reporting capabilities, making it easier to identify patterns and trends based on locations within Lassen County; and allowing County employees to work more efficiently by sharing information with the public in real time.

• GIS Public Web Portal

Task 3: Addressing Tool

Task 3 will include the planning, design, and creation of a GIS tool for all internal addressing responsibilities. The County Surveyor is responsible for assigning addresses in Lassen County, including lands owned by the Susanville Indian Rancheria and the City Planner is responsible for assigning addresses in the City of Susanville, including lands owned by the Susanville Indian Rancheria within City limits. A GIS application is envisioned where addresses can be assigned and maintained internally. Furthermore, addresses could be available on the public web portal so citizens can look up the closest bus stop, what their snow load is, what the zoning/land-use designation is, etc. for a specific address. This tool will contribute to relationship tables that via a request of a query, can quickly show distance to bus stops and multi-modal pathways from the address.

# Task 4: Parcel Layer Updates and Corrections

Task 4 includes parcel layer updates, corrections, and maintenance of parcel layers. The parcel layer geodatabase was created several years ago (20 years ago for the County) and has not been updated in several years during which time numerous lot line adjustments and land divisions have been approved and finalized. Furthermore, the accuracy of the parcel lines displayed in the geodatabase is not as accurate as it should be, when compared to available georeferenced aerial imagery such as National Agriculture Imagery Program. The geodatabase will be updated, working from current Assessor's maps and/or recorded maps (Parcel Maps, Subdivision Maps, Records of Survey, etc), to reflect the most up-to-date Assessor's parcel information and to work with the County and the City to correct the accuracy of the parcel line data. This will lead to better transportation and land-use planning because the upgraded parcels can be tagged relative to the General Plan and the transportation guidelines for our county enabling us to plan for the future with intention aligned with state compliance and our Lassen County community's vision and the Lassen County Transportation Commission's Regional Transportation Plan.

# Task 5: Update Zoning and General Plan Designation Layer

This task will include the update and the corrections to the zoning and general plan designation layer. There have been several rezones (approximately 3 per year for the County and multiple for the City) per year that will need to be added to the geodatabase. There will be some quality assurance to ensure that data was input correctly. Zoning is expected to match the applicable

zoning ordinance for each parcel. Zoning boundaries are established through legal descriptions (including metes and bounds), by drawings shown in the applicable ordinance (based on Assessor Parcel Maps or other map sources) or by a combination of both. By updating zoning and the General Plan designation layer, we enable more access for outside businesses and people looking to relocate to Lassen County. As we update, we can sync our efforts to coincide with the Lassen County Transportation Commission's Regional Transportation Plan and link the data from our addressing tool to maximize ease and access.

Task 6: Update Transportation Layers

Task 6 will include an update and corrections to the roads, transit and multi-modal transportation layers. Updates could include differentiating between maintained versus non-maintained roads and asphalt versus gravel/dirt roads, road conditions, transit routes and stops, adding pedestrian and bicycle facilities to road layers, trail system layers, and emergency evacuation routes.

# Task 7: Data Mining and Data Integration

Task 7 will include data mining and data integration. It is expected that there will be multiple sources including the California Energy Commission GIS Data Hub, United States Forest Service Region 5 Geospatial Portal, Bureau of Land Management Geospatial Business Platform, US Census Mapping files, California State Geoportal, and Esri's Living Atlas. This task will also include the GIS connections between different programs being used in various departments including but not limited to SMARTGov, Megabyte, Parcel Quest, and Google Earth. During the process of working on this grant application and collaborating with our partners, a few simple efficiencies were identified, such as, providing a consistent workflow between the Susanville Indian Rancheria, the City of Susanville, and Lassen County and an opportunity to streamline the advancement of multi-modal transportation, development, and affordable housing as well as, sustainable economic development endeavors.

Task 8: GIS Training

Task 8 will include training, education, and knowledge transfer of staff on how to use available GIS data and layers. This will include but will not be limited to the use of ArcGIS online, ArcGIS Pro, and Field Maps.

# Task 9: Create New GIS Layers

Task 9 will include the creation of new specific GIS data layers determined by the Needs Assessment or through direction from the County, the City of Susanville, the Susanville Indian Rancheria, or the Lassen Transit Service Agency. The new GIS layers could highlight future multimodal transportation corridors assisting in planning and community engagement via web access.

# REQUESTED ACTION

#### BACKGROUND & DISCUSSION

In 2018, the California Air Resources Board (CARB) adopted the Innovative Clean Transit Regulation. is the first of its kind to support these programs. The Innovative Clean Transit Regulation replaced the Fleet Rule for Transit Agencies. The regulation requires all public transit agencies to gradually transition to a 100-percent zero-emission bus fleet and encourages them to provide innovative first and last-mile connectivity and improved mobility for transit riders. This regulation also provides various exemptions and compliance options to provide safeguards and flexibility for transit agencies through this transition.

This initiative is designed to improve long-term air quality throughout the state.

In September 2022, the LCTC received a Sustainable Communities Technical Grant to perform a zero emission vehicle infrastructure feasibility study. This effort is being jointly pursued by both Lassen and Plumas Counties. However, both Commissions will receive separate reports.

In December 2022, after a competitive bidding process, the consulting firm Stantec was selected to do the study. The studies goals are:

- Assessment of current conditions and risk assessment of moving to an electric fleet, including evaluating market conditions of electric vehicles and charging/refueling equipment.
- Identify current conditions of the fleet and feasibility of operating electric vehicles including evaluating current operational needs and costs versus operational needs and costs with an electric fleet.

- Stakeholder outreach with relevant agency departments and external partners including utilities, local governments, etc.
- Evaluate current market and determine vehicle options and charging/refueling options.
- Evaluate infrastructure needs and, if applicable, determine best location for charging infrastructure.
- Identify opportunities for the LCTC and PCTC to share charging and/or fueling infrastructure with other transit agencies or fleets (including our federal, state, and local partners)
- Develop a timeline for bus replacement/purchases and infrastructure development.
- Identify routes to electrify in order of feasibility.
- Work with power supplier to identify infrastructure needs for supply.
- Work with fleet maintenance to understand training and equipment needs.
- Develop a funding plan/assessment.

Since the beginning of this effort Stantec has met with a number of stakeholders in the region, including but not limited to:

- Lassen County
- City of Susanville
- Lassen Rural Bus
- Lassen Municipal Utilities District
- LCTC Technical Advisory Committee
- Local medical facilities
- Chambers of Commerce
- School districts

The study is nearing completion. This update will provide more detail on the study goals, methodologies, and next steps.

# **NEXT STEPS**

Staff and the consultant will bring the final report to the Commission at your January 2024 Regular Meeting.

# **REQUESTED ACTION: By Motion, Adopt the 2023 Regional Transportation Plan and Environmental Document**

# **PAST ACTION**

LCTC staff have completed the Final Lassen County 2023 Regional Transportation Plan and Initial Study Checklist/Proposed Negative Declaration. The Draft RTP was presented at the October 10<sup>th</sup> meeting for review and discussion. The RTP and Environmental Document were available for review and comment from October 6 - November 6 and circulated through the State Clearinghouse as required. Comments received on the Draft RTP and Environmental Document have been incorporated into the Final RTP.

# BACKGROUND/DISCUSSION

One of the major planning responsibilities of the LCTC is the development of the Regional Transportation Plan (RTP). The RTP serves as the planning blueprint to guide transportation investments in Lassen County involving local, state, and federal funding over the next twenty years. Transportation improvements in the RTP are identified as short-range/constrained (2023-2033) or long-range/unconstrained (2034-2044). The RTP must be updated every five (5) years to comply with Caltrans guidelines and be eligible for many sources of funding. The last RTP update was adopted in 2017. Any transportation capital improvement projects funded with state or federal funds must be identified in the RTP.

The overall focus of the 2023 RTP is directed at developing a coordinated and balanced multi-modal regional transportation system that is financially constrained to the revenues anticipated over the life of the plan. The coordination focus brings the County, Caltrans, the City of Susanville, government resource agencies, commercial and agricultural interests, Susanville Indian Rancheria, and citizens into the planning process. The balance is achieved by considering investment and improvements for moving people and goods across all types of transportation including automobiles, public transit, bicycle, pedestrian, trucking, railroad, and aviation.

This 2023 update of the RTP did not significantly change the scope or goals of the prior RTP. Changes to the RTP from the Draft version to the Final version include:

- Highlighting certain active transportation projects deemed particularly important for the region
- Clarified description of the role of the LTSA
- Expanded description of rail and freight
- Clarification of some Caltrans projects
- Updated traffic volume data
- Strengthen discussion on wildlife connectivity concerns as suggested by the US Fish and Wildlife comment letter on the Environmental Document
- A variety of clerical error corrections and clarifications

Capital Program – Overview and Discussion

# REQUESTED ACTION

# BACKGROUND & DISCUSSION

Senate Bill 125 (SB 125) amended the Budget act of 2023 to create a new one-time source of transit funding to address operational funding shortfalls created from the reduction in transit ridership during the COVID-19 pandemic and capital needs. Approximately \$5.1 billion of funding will be distributed by formula over four years and administered by Regional Transportation Planning Agencies (RTPAs), such as the Lassen County Transportation Commission (LCTC) to identify and program regional transit operations and capital projects.

The SB 125 funding will be distributed through two programs: the Transit and Intercity Rail Capital Program (TIRCP) and the Zero Emission Transit Capital Program (ZETCP). Each program has slightly different project eligibility and reporting requirements and is briefly summarized below:

- The TIRCP is an existing competitive transit grant program created to fund transformative capital improvements to California's intercity rail, bus, ferry, and rail transit systems. Eligible projects may include the purchase of new rolling stock, service integration, capital facilities, mobile or contactless payment systems. All capital projects must increase ridership and reduce GHG emissions.
- The ZETCP is a new program that funds projects relating to the purchase and and/or construction of zero-emission transit equipment, zero-emission vehicles and refueling infrastructure.

The SB 125 funds may also be used for transit operating expenses within its jurisdiction that prevent service cuts and increase ridership, including those related to ensuring safety and state of good repair of the vehicles and infrastructure necessary to operate service, as well as those that pay for free and reduced fare programs.

# **Program Requirements**

In order to access the funds, LCTC is required to submit an initial allocation plan identifying the projects to be funded to the California State Transportation Agency (CalSTA) by December 31, 2023. The initial allocation plan is not required to fully allocate all funding, but any projects requesting funding in FY 2023/24 must be included in the plan. A short-term financial analysis of the transit systems is also required if SB 125 funds will be used for transit operating support between FY 2023-2024 and FY 2026-2027. Amendments to the allocation plan are allowed on a rolling basis to include additional projects or modify the list due to changing priorities.

Following the submittal of the initial allocation plan, LCTC will be required to complete the following:

- Conduct annual financial and transit service quality analyses.
- Post monthly transit ridership levels to the LassenCTC.Com website.
- Coordinate with SB 125 recipients to prepare annual progress reports.
- Submit and receive approval of a one-time, long-term financial plan by June 30, 2026, that addresses the approach to sustain the region's transit operations absent additional discretionary or nonformula state funding to maintain eligibility for future TIRCP funding in the 2026-27 fiscal year and beyond.

The SB 125 guidelines allow for up to 1% of funding, or \$41,067, to be utilized by the RTPA to administer the program and prepare a long-term financial plan for the transit system.

# Lassen County Regional Share of SB 125

Lassen County's regional share of the total \$5.1 Billion available statewide is approximately \$12.3 million.
